

MODEL RELEASE FORM

This Model Release Agreement (“Agreement”) is entered into between:

Studio Allegory Intimacy Research Ltd. (“Studio”),

Renée Gebhardt (“Photographer” – Artist name: Renée de Sans),

and

Participant/Model Name: _____ (“Participant”).

1. Grant of Rights

The Participant grants to the Studio and the Photographer a non-exclusive, perpetual, worldwide, royalty-free license to photograph, record, and use their likeness, image, voice, and/or appearance (the “Content”) for the purposes outlined in this Agreement.

2. Ownership & Usage Rights

a. Studio Allegory Rights

The Participant agrees that all photographs and media created during the shoot are owned by the Studio and/or the Photographer. The Studio is granted the right to use, reproduce, publish, display, and distribute the Content for:

- Advertising and marketing (including social media, website, print, and promotional materials)
- Educational and informational purposes
- Portfolio use

b. Participant Rights (Private Use)

The Participant is granted a non-transferable, non-commercial license to use the Content for personal, private use, including:

- Personal social media accounts
- Private sharing with friends, partners, or community

The participant is required to credit the photographer as “Renée de Sans” as well as Studio Allegory for each use of the Content.

c. Commercial Use by Participant

The Participant agrees that any commercial use of the Content requires prior written consent from both Studio Allegory Intimacy Research Ltd. and the photographer.

3. Consent & Capacity

The Participant confirms they are at least 19 years of age and participating voluntarily with informed consent.

4. Sensitive Content Acknowledgment

The Participant acknowledges that the Content may include themes of intimacy, kink, or nudity, and may be publicly viewable.

5. Withdrawal of Consent

Consent may be withdrawn for future use with written notice, though previously published materials may not be retractable.

6. Release of Liability

The Participant releases the Studio and Photographer from claims arising from permitted use of the Content.

7. Privacy

Personal information will be handled in accordance with applicable privacy laws in British Columbia and Canada.

8. Governing Law

This Agreement is governed by the laws of British Columbia and Canada.

9. Entire Agreement

This document constitutes the entire agreement.
